Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulation, 2015, and other applicable provisions, if any, this is to inform you that the meeting of the Board of Directors of the Company was held today i.e. Tuesday, 27th December, 2016, commenced at 04:00 pm and concluded at 1:15 pm and the Board, inter-alia, had considered and decided the following businesses:

- 1. Realignment and Restructuring of the Company and its four wholly owned subsidiaries, namely, BLB Commodities Limited, BLB Global Business Limited, Caprise Commodities Limited and Sri Sharadamba Properties Limited. It was considered that Company is carrying various businesses including, financial & capital market, commodities market and real estate, directly or through these four subsidiaries. But over the period, there has been various overlaps and duplicity in businesses within the group. Similarly, there have been substantial changes in the business dynamics over the period which requires a comprehensive analysis and review of the business models for long terms benefits of all the stake holders.
- 2. Considering the overall realignment and restructuring of the Company and its subsidiaries, it is decided to:
 - a. To withdraw the Scheme of Merger and Amalgamation of M/s Manu Properties Pvt. Ltd. with the Company.
 - b. Withdrawal of Voluntary Delisting application filled with BSE Limited.
- 3. Any other item.
