Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform that Sh. Brij Rattan Bagri, Promoter and Managing Director of the Company, has informed the Company on March 18, 2026 about receipt of a Show Cause Notice (SCN) by him on March 13, 2026 on e-mail (without annexures) and March 17, 2026 through post (complete set along with annexures) from the Securities and Exchange Board of India under Rule 4(1) of the SEBI (Procedure for Holding Inquiry and Imposing Penalties) Rules, 1995.

The said Show Cause Notice pertains to alleged violation of Regulation 3(1) of SEBI (Prohibition of Insider Trading) Regulations, 2015 in the scrip of the Company.

Sh. Brij Rattan Bagri has informed the Company that the matter is personal to him, that he is in the process of seeking appropriate legal advice, and that he will take appropriate steps in the matter.

The Company clarifies that the aforesaid matter does not have any impact on the operations or financial performance of the Company.

This disclosure is being made in the interest of good corporate governance and transparency.
